## **CURRICULUM VITAE**

Dr Nigel Colbert is a Consultant Clinical Paediatric Neuropsychologist. He holds the prestigious Qualification in Neuropsychology (QiCN) awarded by the British Psychological Society and appears in the Specialist Register of Clinical Neuropsychologists (SRCN)\*. He is a Chartered Psychologist and registered with the Health and Care Professions Council.

He has specific training in paediatric neuropsychology incorporating post-accident assessment and treatment planning. He utilises neuropsychological models together with applied behavioural analysis principles for the rehabilitation of complex: emotional, behavioural, social and cognitive challenges following brain injury, both acquired and developmental.

He has also specialised in the psychological assessment and intervention for young adults and children. Specifically, He has trained in Cognitive Behaviour Therapy (CBT) and Eye Movement Desensitization and Reprocessing (EMDR). Both these approaches are advocated in recent NICE guidelines for posttraumatic stress disorder (PTSD). Specialist therapeutic areas are: post trauma syndrome, depression, anxiety, phobia and stress.

He has NHS, charity and independent provider experience, consulting with a range of care and support providers.

He is a founding partner together with a Registered Educational Psychologist, of Clinical, Educational &Neuropsychology Services (CENS) Ltd. That partnership provides comprehensive professional psychology services to children and young people.

Lancashire, Child and Adolescent Mental Health Service (CAMHS) Intensive Support Team. That unit provided therapeutic and educational programmes to young people with highly complex needs throughout East Lancashire. In that role, he practised Cognitive Behavioural Therapy and EMDR; as well as providing neuropsychological assessments and intervention programmes.

In 2004, he established an independent practice for children and young people with complex psychiatric disorders and also with acquired or developmental neurological disorders.

In April, 2007, he was appointed "Consultant Paediatric Neuropsychologist" at the David Lewis Centre, Cheshire. In September 2008, he was further appointed "Head of Psychology and Behavioural Support Services" again at the David Lewis Centre. The "David Lewis-National Epilepsy Centre" was the largest UK independent provider of educational, medical and treatment services for adults and children with epilepsy, neurological disorders both acquired and developmental, learning disability disorders and challenging behaviour. In his role at the David Lewis Centre he was responsible for the assessment and rehabilitation programs for children and young people with a wide range of both developmental and acquired neurological impairment, including traumatic brain injury.

In March 2010, he was appointed 'Consultant Neuropsychologist' at the Transitional Rehabilitation Unit Ltd, a leading independent provider of neuropsychological assessment and rehabilitation services.

In May 2011, he became a full-time Director and Practitioner with Clinical, Educational &Neuropsychology Services (CENS) Ltd.

Dr Colbert has taught regularly on the Lancaster University Doctorate course in Clinical Psychology. He is invited to speak on topics related to acquired brain injury and rehabilitation. He has presented at national and international conferences organised by interest groups including the Child Brain Injury Trust and the Institute for Applied Behaviour Analysis. In 2008, he was the consultant on psychology

and behavioural interventions to the Government's 'Learning and Skills Improvement Service'.

Dr Colbert has a first class honours degree recognised by the British Psychological Society. # \* Instructions on the Professional Use of BPS Membership Grades and Titles in relation to Neuropsychology (February 2013)

#### **Clinical Neuropsychologist or Consultant Clinical Neuropsychologist**

At present, these are not legally protected titles although they are commonly used within public, independent and medico-legal settings to identify professionals with highly-specialist expertise in the diagnosis, prognosis and rehabilitation of brain-behaviour relationships. BPS professional guidelines are that Clinical Neuropsychologists should meet the competency standards examined by the BPS Qualification in Clinical Neuropsychology (QiCN) (*Competency Framework for the UK Clinical Neuropsychology Profession,* 2012).

Upon completing the QiCN, professionals who are registered with the Health and Care Professions Council (HCPC) are entitled to join the BPS *Specialist Register of Clinical Neuropsychologists* (SRCN). Clinicians who had appropriate experience at the initiation of the QiCN were grand-parented onto the register. The SRCN is publically available on the BPS website and the HCPC have noted that this serves an important function in protecting the public by identifying appropriately qualified Clinical Neuropsychologists.

Therefore, the BPS DoN strongly recommends that all appropriately qualified Clinical Neuropsychologists should join the SRCN to support public safety. To refer to oneself as a Clinical Neuropsychologist, Consultant Clinical Neuropsychologist or to offer Clinical Neuropsychology services whilst not listed on the SRCN is acting against this professional & ethical guidance. Professionals undertaking QiCN training should always have their clinical neuropsychological work supervised by a member of the SRCN.
